ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Losik for non-furnishing of 23(twenty three) point information regarding State Own Revenue(SoR) Schemes in the entire Kurung Kumey District during 2022-23, 2023-24 by the PIO, o/o the District Panchayat Development Officer, Koloriang, Kurung Kumey District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 12.09.2024:

This appeal was heard on 02.07.2025 wherein the appellant, Shri Bamang Losik and Shri Chera Tapung, Panchayat Technical Assistant (PTA), representing the PIO were present through VC.

This Commission, upon hearing the parties and on noticing that the documents/information sought for by the appellant were not covered under the exemption provisions of the RTI Act 2005, directed the PIO and the DNO, Shri Chera Ngoya (PTA), in the interim, to provide the appellant the remaining documents within 3(three) weeks from 02.07.2025 i.e. on or before 23.07.2025 and also directed the appellant to intimate this Commission of the receipt of the documents within one week from 23.07.2025 for further consideration of the appeal.

The appellant, vide letter dt. 24.07.2025, had complained that inspite of this Commission's order dt.04.07.2025, the PIO has neither complied with the order nor given any reason for non-compliance of the order. He, therefore, pleaded for initiating necessary action under section 20(1) of the RTI Act and also under section 19(8)(b).

This Commission also holds that the non-compliance of the order dt.04.07.2025 by the PIO is a serious matter making out a case attracting the penal action under the relevant provisions of the RTI Act.

This Commission, therefore, deems it appropriate to hear this appeal again on 03.09.2025 wherein the DNO-cum-PIO must be present failing which necessary penal shall be initiated against him. In the meantime the left out information shall be provided to the appellant, as already directed in earlier order and furnish/ produce the compliance report on 03.09.2025.

NOW THEREFORE, you are hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC on the 3rd Sept., 2025 (Wednesday) at 10.30 am to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
