The 11th hearing is held today on 28th May, 2024. Shri S. T. Zara, the PIO –cum-DDSE, Govt. of A.P., Capital Complex, Itanagar, Arunachal Pradesh and the Appellant Shri Nabam Tapak are absent. Further, the SPIO is directed to comply with the directions made on the 10th hearing held on 2nd April, 2024. The court is adjourned for next date of hearing.

If the SPIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.
