**ORDER**

The 1<sup>st</sup> hearing held on **24<sup>th</sup> April, 2025** related to the **APIC No-359/2024**. The Appellant Shri Khya Changrang is present. The PIO is present through online mode during the hearing before the Commission.

**Heard the Appellant and the APIO;**

The Appellant stated before the Commission that he has filed the Form-A application to the PIO who is the Chief Engineer, RWD, Western Zone on 02.09.2024, upon receipt of the application the PIO forwarded the application of the Appellant to the Superintendent Engineer, RWD, Rupa Circle with an order to provide the information(s) as sought to the Appellant. Upon which the PIO-cum-SE Rupa Circle failed to provide the information(s) within 45 days, but the SE, RWD, Rupa Circle replied to the Chief Engineer with a copy to the applicant Shri Khya Changrang on 30.09.2024, stating that the information(s) cannot be furnished citing that they are personal information(s) and exempted under Section 8(1) Sub-Section (j) of RTI, Act, 2005.

**Heard the PIO:**

The PIO-cum-SE, office of the Chief Engineer, Headquarter Itanagar stated before the Commission that the information(s) can be furnished if the Commission order so, but, the information(s) sought by the Appellant are personal information(s) of an individual which are also termed as third party information(s) which can only be provided with due permission by the individual/ agencies.

After hearing both the parties and going through the Form-A application of the Appellant;

**The Commission Observes;** To furnish the copy of service book is exempted under RTI, Act, 2005, but the other information(s) as sought by the Appellant are not exempted under RTI, Act, 2005.

**The Commission hereby orders;**

- 1) The PIO to provide the detail of appointment order, of Shri Nili Likha Kamin, his service tenure so far, including the copy of promotion order(s), transfer order(s), leave availed till now in service and the scale pay at the time of joining and drawing in the present times now: on or before the next date of hearing, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
- 2) The Appellant to collect the information(s) from the office of the PIO and to intimate the Commission about the information(s) received completely or not, on or before the next date of hearing and to be present on the next hearing, failing which this appeal will be heard ex-parte.
- 3) Both parties to be present in the next date of hearing, and in time, so that the court process is not disarrayed.

**The next date of hearing be fixed on 22<sup>nd</sup> July, 2025' at 2:30 PM (Evening).**
