**INTERIM ORDER/SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho, for non-furnishing of information by the PIO Project Director DRDA Koloriang, Kurung Kumey, Govt. of Arunachal Pradesh. Pin :791118 as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 06/04/2023.

This appeal was listed for hearing for the 5<sup>th</sup> time today on 20/11/24 wherein the Appellant Shri Bamang Pacho is present but the PIO is absent.

In the last hearing on 09/10/24, this Commission, while closing the show cause notice dated 13/09/24 issued to the PIO, had directed the Assistant Project Officer (Technical), the Engineer incharge and Nodal Officer of Model Village under CMAGY (RD), Koloriang, Shri Nangram Logu to furnish the sought for information to the Appellant in terms of Sub-Section -5 of Section-5 of the RTI Act,2005 within two weeks. However, as submitted by the Appellant during the course of hearing today, the PIO did not furnish the information despite reminders.

This Commission, taking serious view of the non-compliance of its order by the said APO (Technical), and in exercise of the powers under Section-19(8) (a) (ii), of the RTI Act, appoint Er. Shri Nangrama Logu, APO (Technical)-cum – Nodal Officer (Model Village Scheme) under PMAGY, o/o the P.D(RD), Kurung Kumey District, Koloriang, as the PIO who shall be summoned for hearing in this particular appeal before this Commission.

Shri Nangram Logu, APO (Technical)-cum-Nodal Officer is, therefore, directed to appear in person before this Commission on 04/12/24 along with the information(s) sought for by the Appellant.
