SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Rakhe Tach & Shri Arun Riya for non-furnishing of information by the PIO / APIO Kurung Kumey Forest Division Koloriang, District Kurung Kumey Govt. Of Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

This appeal is heard for the 3rd time today on 23rd August 2024 as scheduled wherein the PIO Shri D. Basar, DFO, Kurung Kumey Forest Division, Koloriang, District – Kurung Kumey was present and one of the appellants, namely, Shri Rakhe Tach was present.

Heard both the parties and during the course of hearing the Appellant informed that he had received the copies of LOC and sanction orders. As regards copy of DPR, the PIO informed that no DPR is prepared in the implementation of the scheme under non-plan. As regards MB book, and other items of information, the PIO has submitted that some of the documents were seized by the CCF, Banderdewa in a disciplinary case. He further submitted that if the soughtfor information are available in the seized list of documents, he will collect the same and provide to the Appellant. He will also submit a detailed written statement in this regard in the next hearing.

The next date of hearing of this case is fixed on 20/09/2024 (Friday) at 02.00 PM.
