The **1st hearing** was held on **29th January, 2025** related to the **APIC No-1045/2023 (Appeal)**. Appellant, Shri Sangkung Jonah present during the hearing but the PIO-cum-Jt. Director, Elementary Education, Itanagar found absent without any intimation to the Commission.

It is seen from the case record that hearing was conducted in the First Appellate Authority and information was provided to the appellant. But the appellant who is present today started that he has sought the information regarding promotion list of Primary Teacher 2004 & 2005 batches and seniority list of 2004 & 2005 bathes. But the Director of Elementary Education has denied furnishing the information stating that promotion procedure was done upto 1997 batch through 2022-2023 DPC.

But the appellant stated today that promotion as ATA to JT as per the statement made by the appellant DPC for 2004 & 2005 batches have already been done and the documents enclosed in the case record.

After going through all the case record and heard from appellant, the PIO is directed to appear in person before the Commission in the next date of hearing.

The Commission adjourned the hearing and fixed next date of hearing on **17/03/2025 at 1030 hours.**
