The 1<sup>st</sup> hearing was held on 29<sup>th</sup>January, 2025 related to the APIC No-1045/2023 (Appeal). Appellant, Shri Sangkung Jonah present during the hearing but the PIO-cum-Jt.Director, Elementary Education, Itanagar found absent without any intimation to the Commission.

It is seen from the case record that hearing was conducted in the First Appellate Authority and information was provided to the appellant.
