SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 30 point information C/o "L025-PMGSY Road from PMGSY Road (Staging Hut Krosam to Khrawit village during the financial year 2024-25 by the PIO, o/o the Executive Engineer, RWD, Hawaii Division, District Anjaw, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 01.11.2024.

This appeal was listed for 2(two) times on 4th June, 2025 and 23.07.2025. On 4th June, 2025, wherein the appellant was present in person and the PIO, Er. Shri Bajai Pul, EE was present through VC, this Commission, after hearing the parties had directed the PIO to provide the information duly indexed and countersigned through a messenger within 1(one) week from 04.06.2025. The appellant was also directed to intimate this Commission of the receipt of the documents within one week from the date of receipt of the documents.

The appellant, vide letter dt.17.06.2025, informed that he has received the documents from the PIO on 07.06.2025, but complained that the following documents are either not furnished or are incomplete /unsatisfactory.

1. Sl. No.1: Not furnished;
2. Sl. No.4 and 5 : Replies not justified;
3. Sl.No.6, 10, 12, 16,17 and 18: Not furnished;
4. Sl.No.19,29,21,25,26 and 27: Not satisfied with the replies.

This appeal was, therefore, listed again today on 23.07.2025 but both the PIO and the appellant are absent. This appeal, hence, listed again on 27.08.2025 and it is made clear that the appeal shall be closed *repeat* shall be closed if the appellant does not appear on that date.

NOW THEREFORE, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC 27th August, 2025 (Wednesday) at 10.30 am** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
