ORDER

1st hearing held on 5th Nov/2023 (Appeal) related to the **APIC.No-636/2023**. The Appellant Shri Tamchi Gungte present during the hearing and the PIO heard through the online mode.

Heard both the parties.

The Appellant stated before the Commission that he has received some of the information from the PIO, but the information sought under serial no. 4,5,6,7,8,9 14 & 15 are not received till date.

The PIO stated before the Commission that the information sought by the Appellant in his form 'A' application have been already sent to the Appellant through post office on dated 23/9/2024. The information sought in the serial no -3 as quoted in form 'A' application have not been furnished, as it was not implemented by the District Horticulture Officer West Siang District Aalo.

After hearing both the parties and after going through the Form 'A' application of the applicant the Commission Ordered ;

- (i) The PIO to provide the information to Appellant sought under Serial No.4,5,6,7,8,9,14 & 15 on or before the next hearing. **Failing which necessary action shall be initiated shall be against the PIO as per the provisions of the RTI Act, 2005.**
- (II) Next date of hearing has been intimated to both the parties. No formal notice required to be issued.
The Commission ordered;
- (III) **The next date of hearing is fixed on 17th December, 2024 at 1:30 PM (Afternoon)**
