SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Pisa Tapam for non-furnishing of below mentioned information by the PIO, o/o the PD (RD) Koloriang, Kurung Kumey District Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 22.08.2024.

Details of information required:

1. Technical sanction order copy.
2. Name and address of contractors/firm/name of Firm owner/proprietor.
3. NIT copy if possible.
4. Details bid documents of contractor (Technical & Financial).
5. Name of work with Geo tag report of each project.
6. Details of payment with money receipt of contractors i.e. cheque book, counter foil/deposit Challan.
7. Account statement of department.
8. DPR copy.
9. MB book.
10. First and final bill.
11. Photocopy of work site from starting to end / certified photocopy of work site by the concern officer.

Period for which information asked for: 2021-24

This appeal is listed for 4th time today on 06.06.2025, the earlier 3 times being on 04.04.2025, 23.04.25 and 21.05.25.

On 04.04.2025 and 23.04.25 neither party was present but on 21.05.2025, the appellant was present in person but the PIO was again absent who, however, informed during the hearing that due to his pre-occupation in an enquiry being conducted by the Anti Corruption Bureau (formerly SIC) in a 15th Finance Commission related case he was not able to attend the hearing. The PIO, however, submitted that the requested documents/information shall be provided to the appellant by 30th May, 2025.

The appeal was hence, adjourned to 06.06.2025, but today also none of the parties attended the hearing but the appellant informed vide his letter dt.05.06.2025

that due to health issue, he will not be able to attend the hearing and requested for adjournment of the hearing.

This appeal is, therefore, listed again on 11.07.2025.

You are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on 11th July, 2025 (Friday)** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense. It is made clear that if the parties, more particularly, the appellant fails to attend the hearing on the aforementioned date, this appeal shall be closed without further notice.

NOW THEREFORE, take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
