**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte, for non-furnishing of information by the PIO o/o the Executive Engineer (RWD), Likabali Division, Lower Siang District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 27.04.2023.

This appeal is heard for the 7<sup>th</sup> time today on 6<sup>th</sup> December, 2024.

In the last hearing on 8<sup>th</sup> November, 2024, wherein the Appellant, Shri Tamchi Gungte and Er. Shri Kenli Nyorak, JE (RWD), Likabali Division were present and Er. Shri Gambi Karbak, the PIO, o/o the EE (RWD) Aalo attended the hearing through video conference, this Commission, on the suggestion of the PIO, o/o the EE (RWD) Aalo and in exercise of power under Section 19(8)(a)(ii) of the RTI Act, 2005, the E.E (RWD) Likabali Division was made the PIO in this case and was provided with the copy of the application form 'A' submitted by the appellant to enable the PIO to furnish the left out information, if any.
