After Hearing the PIO and going through the Form A application of the Appellant, the Commission ordered;

- (i) The PIO to provide all the information(s) as sought in his application except the information pertaining to Serial no. 7, 14 & 15 as these information(s) are exempted from RTI Act under Section 8(g). ***Failing which necessary action shall be initiated against the PIO as per the provision of RTI, Act, 2005.***
- (ii) ***To issue summon to the Appellant to appear in person or through online mode. Failing which his appeal shall be decided ex-parte.***
- (iii) Next date of hearing has been intimated to the PIO. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 19th December, 2024 at 10:30 AM (Morning)
