**ORDER**

The 2<sup>nd</sup> hearing held on 16<sup>th</sup> January, 2025 related to the APIC-No-943/2023. The Appellant Shri Riya Taram is present during the hearing. The PIO-cum-EE, WRD, Aalo Division, West Siang District, Govt. of Arunachal Pradesh, is present through online mode during the hearing before the Commission.

**Heard the Appellant and the PIO:**

The PIO stated before the Commission: that he is newly posted in the office of the PIO and the present appeal was preferred against the previous PIO. The PIO has sent a letter to the Appellant within prescribed period of 30 days on his given address for depositing requisite amount of Rs. 79,232/- (Rupee Seventy Nine Thousand Two Hundred Thirty Two) only to the office of the PIO and collect the information(s) sought under Form-A application of the Appellant. But, the Appellant has not paid the fees to collect the information(s) as sought by him, till now.

**The Commission ordered:**

- (i) The Appellant to collect the information(s) from the office of the PIO by paying an amount of Rs. 79,232/- (Rupee Seventy Nine Thousand Two Hundred Thirty Two) only, as the fee for the information(s) sought, and inform the Commission about complete or in-complete information(s) received on or before the next date fixed.
- (ii) Notice for next date of hearing need not be issued to both the parties as they are present personally during the hearing.

**The Commission ordered;**

**The next date of hearing be fixed on 18<sup>th</sup> March' 2025 at 2:30 PM (A/Noon).**
