ORDER

WHEREAS, in connection with the APIC-No. 220/2024, your personal appearance is required before the Commission on 30th January, 2025 at 10:30 AM. The 3rd hearing held on 21st November, 2024 related to the APIC No-220/2024. The Appellant Shri Taba Tokur is absent. The PIO-cum-Managing Director, (MD), State Co-operative, APEX Bank, Naharlagun, Govt. of Arunachal Pradesh, found absent during the hearing without intimation to the Commission for his inability to attend the hearing. which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the RTI, Act,2005, which is a statutory duty binding upon the PIO.

The Commission observed:

Due to absence of both the parties, the hearing is posted to the next date of hearing.

The Commission ordered:

- (i) To issue summon notice to the Appellant to attend in the next hearing in person or through online mode.
- (ii) To issue summon notice to the PIO to attend in the next hearing, failing which an appropriate action will be initiated against the PIO, as per the provision of RTI, Act, 2005.

The next date of hearing be fixed on 30th January' 2025 at 10:30 AM (Morning)
