**SUMMON**

**WHEREAS**, in connection with the **APIC-No. 367/2024**, your personal appearance is required before the Commission on **22<sup>nd</sup> July, 2025 at 02:30 PM**. The 1<sup>st</sup> hearing held on 24<sup>th</sup> April 2025, related to the **APIC No-367/2024**. The Appellant Shri Tamchi Gungte, present during the hearing but PIO-cum EE (PWD) Naharlagun found absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

**Heard the Appellant.**

The Appellant stated before the Commission that PIO has provided the information(s) applied for in the **serial no, 2,,3 & 4** but the information(s) applied for in **serial no. 5,6 & 7 of the form'A'** are not provided to the Appellant ill date.

After hearing the Appellant and going through the form'A' application to the Appellant the Commission hereby orders;

- (i) To send summons to the PIO, to attend the hearing on the next date, **falling which necessary action will be initiated against the PIO as per the provisions of RTI Act 2005.**
- (ii) The PIO to provide the information(s) pertaining to **serial no.1, 5, 6 & 7** to the Appellant on or before the next date of the hearing. **Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act 2005.**
- (iii) The next date of hearing has been intimated to the Appellant. No formal notice required to be issued.

**The next date of hearing be fixed on 22<sup>nd</sup> July 2025 at 2:30 PM.**
