1. Name of all beneficiaries of PMAY-G along with their detail payments reflecting each and every beneficiaries fund transfer orders and status of house from 2016 to 2022.
2. Copy of completion reports of all PMAY-G, beneficiaries who's house have been completed as per the central government guidelines.
3. Copy of central government guidelines on PMAY-G, Scheme.

4. Period: 2016-2022.

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records, observes that PIO remained absent consecutively for last six hearing including today. It is brought to the notice of the higher public authority who can take action against the PIO under para 41 of guidelines to the first appellate authority.

In view of the above facts and circumstances, and as laid down at para-41 of the Guidelines for the Appellate Authority issued by GoI and State Govt. with OM No. AR-111/2008 where it says:

" If any case, the SPIO does not implement the order passed by the appellate authority and the appellate authority feels that intervention of higher authority is required to get his order implemented, he should bring the matter to the notice of the officer in the public authority competent to take action against the SPIO. Such

competent officer shall take necessary action so as to ensure implementation of the provisions of the RTI Act".

Accordingly, it is brought to the notice of the Deputy Commissioner, Koloriang, Kurung Kumey District, who shall ensure the PIO to furnish the information to appellant within 3 weeks from the date of issue of this order i.e. on or before 28.11.2024.

In default, action against the PIO under section 20 of the RTI Act. 2005 shall be initiated.

The appellant shall serve a copy of this order to the PIO and the Deputy Commissioner, Koloriang, obtain written acknowledgement and submit a copy of it to this commission.

Hearing adjourned. Next date of hearing shall be fixed after receipt of compliance report of this order by the Appellant and PIO.
