ORDER

The 4th hearing held on **26th November, 2024** related to the **APIC No-100/2024**. The Appellant Shri Riya Taram and party represented by one of the party during the hearing but, PIO found absent without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO beside public duties, also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI, Act 2005, which is a statutory duty binding upon the PIO.

In the last hearing the PIO stated before the Commission that as per the order passed in the last hearing on dated **06/06/2024** all the information(s) of the block year **2020-2021** are ready in his good office and provided the letter written to the Appellant to collect the information(s) from the office of the PIO before the Commission, during the hearing.

Due to absence of PIO, the Commission could not proceed the hearing of this appeal and ordered;

- (i) To PIO to provide all the information(s) to the Appellant on or before the next date of hearing as sought in his form 'A' application. Failing which action section 20(2) shall be initiated against the PIO as per the provision of RTI Act, 2005.
- (ii) The Appellants to collect all the information(s) from the PIO's office on or before next date of hearing and convey to the Commission received full information(s) or not as applied.
- (iii) The next date of hearing has been intimated to the both parties. No formal notice required to be issued.

The Commission ordered;

The next date of hearing is fixed on 4th February, 2025 at 1:30 PM (Afternoon)
