INFORMATION

The PIO stated that all information(s) records are not available in the office of the PIO. The Appellant stated that he want to ascertain the veracity of some documents obtained from the office of the DLRSO, Namsai and to know if the DLRSO, Namsai is delegated with power by the Director of Land Management, Govt. of Arunachal Pradesh to issue those documents/certificates. And that: if the DAG number system/CHITHA REGISTER of 1968 is still a valid Land Document and if it is incorporated under the AP (Land Settlement and Records) Act, 2000 and if still valid, to provide a copy of the order/gazette notification for the inclusion/incorporation of the same in the Arunachal Pradesh (Land Settlement and Records) Act. 2000.

After Hearing the Appellant and the PIO and going through the Form- A application of the Appellant, the Commission ordered;

- The PIO to provide in written to the Appellant, the information he has sought, (i) within a week time from today, and failing which action will be initiated under Section 20(2) as per the provision of RTI, Act, 2005, against the PIO.
- The Appellant after receipt of the information(s), to intimate to the Commission (ii) whether he has received the information(s) or not, on or before the next date of hearing.
- Next date of hearing has been intimated to the parties. No formal notice required (iii) to be issued.
