**SUMMON ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from **Smti Tongyang Mema Bengia, Lower Chimpu Itanagar, PO- Chimpu, PS- Itanagar, Arunachal Pradesh** for non-furnishing of information by **the PIO –cum- EE, RWD, Laying Yangte Division, Kurung Kumey District, Govt. of Arunachal Pradesh** as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

During the last hearing held on the 12/06/2024. The Appellant was present but the PIO was absent. During the hearing of this case the Appellant has informed the Commission that, she has received the Compensation amount from the PIO, but she has not yet received the left-out information from PIO. In absence of the PIO the case couldn't be heard further. The PIO is hereby directed to provide the left-out information(s) as sought for by the Appellant without further delay and he is also directed to deposit the receipt (Treasury Challan) of the Penalty amount of Rs 25,000/-(Rupees Twenty-five thousand) only as directed in the 4<sup>th</sup> hearing of this case held on 31<sup>st</sup> Jan,2024 on or before the next date of hearing of this case.

**The next date of hearing of case is fixed on the 3<sup>rd</sup> July,2024 (Wednesday) at 1000 hrs.**
