SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tall Yitor, for non-furnishing of information by the PIO DFO Daporijo Forest Division Upper Subansiri District Govt. of Arunachal Pradesh. Pin :791122 as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

This appeal is heard for the 2nd time today on 24/07/24 wherein the Appellant Shri Tall Yitor was physically present and the PIO, the DFO, Daporijo, Shri Boken Pao attended the hearing through Video Conference (VC).

The Appellant submitted that as directed by this Commission in the 1st hearing on 14/06/24, he had tried to meet the PIO to collect the remaining information(s). He even visited the Residence of the PIO for the purpose. However, he did not receive any positive response from the PIO in view whereof the Commission should initiate stringent action including imposition of Penalty and Compensation under the relevant provisions of the RTI Act,2005 for the harassment he had to face. He also submitted a written complaint dated 24/07/24 in this regard.

The PIO in his submission through VC, however, stated that most of the information(s) numbering (a) to (m) sought by the Appellant in his application dated 07/06/23 were already furnished to the Appellant and that some information(s) which were either not furnished or furnished incomplete/unclear will be furnished to the Appellant for which he advised the Appellant to visit his office on 29/07/24 for collection.

The Commission considered the submission of both the Appellant and the PIO and directs the Appellant to collect the information(s) from the PIO and intimate his satisfaction or otherwise on or before the next date of hearing of this case which is fixed on **28/08/2024, Wednesday at 10.30 HRS.**

NOW THEREFORE, PIO, DFO Daporijo, Forest Division, Upper Subansiri District, Govt. Of Arunachal Pradesh is hereby summoned to appear in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person or online on the above-mentioned date and time without fail.
