Summon Notice.

The 2nd hearing held on 11th February 2025, related to the APIC No. 1125/2024. The PIO-cum-Executive Engineer Public Health Engineering Department (PHED) Koloriang Division, Govt. of Arunachal Pradesh, present in person during the hearing but the Appellant Shri Sangha Rade found absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing.

Heard the PIO.

The PIO stated before the Commission that he has brought all the information(s) as sought by the Appellant in his form 'A' application and wanted to hand over all the information(s) to the Appellant before the Commission but Appellant is absent and so, he cannot hand over the information(s).

Pursuant to the above circumstances, the Commission hereby orders;;

- (i) To issue summons to the Appellant to be present in person or through online mode in the next date of hearing. And Appellant to collect the information(s) from the office of the PIO on or before the next date of hearing. **Failing which his appeal shall be decided Ex-parte.**
- (ii) The PIO to provide all the information(s) to the Appellant on or before the next date of hearing as sought in his form 'A' application. **Failing which action under suitable section shall be initiated against the PO as per the provision of RTI Act 2005.**
- (iii) The next date of hearing intimated to the PIO as he is present during the hearing. And summon sent to the Appellant as he is absent during the hearing.

Due to absence of the Appellant, the Commission could not proceed with the hearing of the appeal.

The Commission hereby orders;

The Commission fixed the next date of hearing on 17th April '2025 at 10.30 AM (Morning) and adjourned the hearing.
