#### **ORDER**

This is a Complaint under Section 18(1) of RTI Act, 2005 received from Shri Tania June for denial of information by the PIO, o/o the Chief Engineer, PHE & WS, Western Zone, Govt. of A.P Itanagaras sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 16.11.2024.

The complainant herein had requested the PIO for the above mentioned information but the PIO, vide letter dt.13.12.2024, rejected their request on the ground there is no such fund allotted during the period mentioned in his RTI application.

Aggrieved with the response of the PIO as above, the complainant filed this complaint under section 18 of the RTI Act. 2005 which has been registered as APIC-16/2024 and listed for hearing on 14.02.2024 wherein the complainant, Shri Tania June and the PIO, Er. Shri Hogduk Ete, Superintending Engineer were present in person.

Since the primary request of the complainant/appellant was to obtain the information, this Commission explained the provisions of section 18 and section 19 of the RTI Act to the complainant / appellant who then expressed his desire to have this Complaint heard as appeal instead of complaint. Accordingly, this complaint has been converted into appeal and heard the parties.

The complainant/appellant, reiterating his demand for the sought for information from the PIO, pleaded that if no fund has, indeed, been made available to the PIO's department during the period mentioned in his RTI application, the PIO be directed to furnish a declaration to that effect by way of an Affidavit.

This Commission, upon hearing the parties, and on perusal of the provisions of the Arunachal Pradesh Information Commission (Appeal Procedure) Rules, 2005, finds that the prayer of the complainant / appellant is found to be justified in terms of rule-5(vi) of the aforesaid Rules. Therefore, this Commission directs the PIO to furnish the declaration as demanded by the appellant and report compliance thereof to this Commission within 2(two) weeks from the date of receipt of this order whereafter the next date of hearing, if required, shall be fixed accordingly.
