**An Appeal Case U/S 19(3) of RTI Act, 2005.
Vide Case No. APIC-234/2024**

Shri Tai Tayu -VS- DY. Commissioner (Legal) cum- PIO Department of Tax & Excise, Itanagar.

Order.

The 1st hearing held on **26th September, 2024** related to the **APIC No-234/2024**. The Appellant Shri Tai Tayu and the PIO present during the hearing.

Heard both the parties.

The PIO stated that, pertaining to the information(s) sought by the Appellant in his form 'A' application he can only provide GST payment details but other information(s) sought by the Appellant are not under his disposal, as he doesn't have the records of the same information(s) and therefore, the PIO stated his incompetency to provide the rest information(s) as sought by the Appellant.

After hearing the PIO, the Appellant agreed with the statement of the PIO and thereby agreed to receive only the information(s) which are with the PIO.

After hearing both the parties, the Commission ordered;

- (i) The PIO to provide the information(s) pertaining to the GST payment to the Appellant on or before next date of the hearing. ***Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act, 2005.***
- (ii) ***The Appellant after receipt of the information(s) to intimate to the Commission whether he has received full information(s) as ordered or not on or before next date of hearing.***
- (iii) The next date of hearing has been intimated to both the parties. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 19th November, 2024 at 2:30 PM (Afternoon)
