## Summon Notice

The 1<sup>st</sup> hearing was held on 9<sup>th</sup> December, 2024 related to the APIC No-246/2024 (Appeal). Appellant present during the hearing, but the PIO found absent without any intimation to the Commission.

As per the First Appellate order dated 02/08/2024, the Principal Secretary has ordered that Shri Tayi Kena PIO-cum-Deputy Secretary (PWD), Itanagar to furnish the following information sought by the appellant Shri Techi Hemu:-

- i. Copy No. NEC/)/Approval/RD/AP-VIII/11<sup>th</sup> Plan/2011/Voll/14 dtd 13<sup>th</sup> March, 2023.
- ii. Copy NEC/FinanceCircular No. NEC/FIN/CAN/12/2022 dated 20<sup>th</sup> Sept' 2022.
- iii. Copy of Revised Estimate for Administrative Approval for Rs. 155.70 Crores as per bread brack up of items of work given in Appendix-I towards the road project "Improvement//Upgradation of Pakke-Seijosa-Itakhola Road (62.00 KM) under NEC-reg.
- iv. Copy of sanction order if any against flood damage for "Improvement//Upgradation of Pakke-Seijosa-Itakhola Road (62.00 KM) under NEC-reg.
- v. Copy of Technical Sanction ordered against Revised Estimate as per Administrative Approval letter No. NEC/(TT%&C)/Approval/RD/AP-VIII/11thPlan/2011/Vol-II/14 dtd 13<sup>th</sup> March, 2023.
- vi. Copy of Technical Sanction ordered against flood damage doe "Improvement/Upgradation of Pakke-Seijosa-ItakholaRoead (62-.. KM) under NEC-reg.

As per the notice dated 10/07/2024by the PIO-cum-Dy. Secretary (PWD), Itanagar has written a letter to the appellant regarding the furnishing of RTI documents. He has stated in the notice that he has been directed to furnish a copy of NEC letter No. NEC (T&C)/Approval/2015-16/03 dated 2<sup>nd</sup> June along with a copy of administrative approval and expenditure sanction amounting to Rs. 166.16 lakhs as sought by the appellant. However, he stated that the details information pertaining to Para A, C, D, E, F &G are not available in the Secretariat PWD Office.

PIO requested appellant to submit a separate application to the concerned public authority for obtaining the rest of the information from them and RTI application submitted in Form'A' by the appellant was returned in original.

PIO is directed to be present in person before the Commission in the next date of hearing and to provide the information as per the order made by the First Appellate Authority if documents are available. If documents are not available as per his notice dated 10/07/2024, to the appellant, the PIO can file an affidavit declaration for non-availability of the documents before the Commission.

Commission adjourned the hearing and fixed next date of hearing fixed on 03/02/2025 at 1030 hours.
