**SUMMON ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from **Shri Bamang Pacho, Forest Park, Near Main Powerhouse, House No. IMC-491, W-10, Itanagar, Arunachal Pradesh** for non-furnishing of information by the **PIO-cum-BDO Damin, Sarli and Koloriang CD Blocks, Kurung Kumey District, Govt. of Arunachal Pradesh** as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

The last hearing of this case was held on 12.06.2024. The Appellant was present but the PIO was absent. During the hearing of this case, it was found that the sought for information by the Appellant is not under the Custody of the present PIO i.e PD, DRDA Koloriang, but with the concerned BDOs of Kurung Kumey District.
