**Summon Notice.**

The 2<sup>nd</sup> hearing held on 16<sup>th</sup> January, 2025 related to the APIC-No-784/2023. The Appellant Shri Nabam Sono found absent during the hearing. The PIO-cum-EE, PHE & WS, Basar Division, Leparada District, Govt. of Arunachal Pradesh, is present through online mode during the hearing before the Commission.

**Heard the PIO:**

The PIO stated before the Commission that he has already written to the Appellant to submit an amount of Rs. 1227/- (Rupees One Thousand Two Hundred Twenty Seven only) as the cost of the information(s) that the Appellant has applied for and to collect the information(s).

That even after the information(s) are ready to be provided to the Appellant, the Appellant has not submitted the fees to the office of the PIO till now.

**The Commission observed:**

The Commission had passed an order dated 12<sup>th</sup> day of November' 2024, ordering the Appellant to pay an amount of Rs. 1227/- (Rupee One Thousand Two Hundred Twenty Seven) only, to the office of the PIO to collect the information(s) sought. Today is the hearing fixed for ascertaining from the Appellant if he has paid the fee and collected the information(s) from the PIO or not. But the Appellant is absent without informing reason for his absence. And therefore, the hearing could not proceed.

**The Commission ordered:**

- (i) The Appellant to collect the information(s) from the office of the PIO by paying an amount of Rs. 1227/- (Rupee One Thousand Two Hundred Twenty Seven) only, as the fee for the information(s) sought, and inform the Commission about complete or in-complete information(s) received, on or before the next date fixed for hearing.

- (ii) Notice for the next date of hearing need not be issued to the PIO as he is present personally during the hearing.
- (iii) Notice be issued to the Appellant to be present personally or through online mode in the next date of hearing, failing which the appeal will be decided ex-parte.

**The Commission ordered;**

**The next date of hearing be fixed on 25<sup>th</sup> Feb.' 2025 at 1:30 PM (A/Noon).**
