**SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, for non-furnishing of information by the PIO –cum-EE, PWD Pakke Kessang Division, Pakke Kessang District, Govt. of Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

The 4<sup>th</sup> hearing of this appeal is held today on 24.07.2024 wherein the Er. Shri. Gunuk Nabam, A.E and the APIO o/o the E.E (PWD), Pake Kessang was present but the Appellant, Shri Riya Taram was absent.

In the 3<sup>rd</sup> hearing on 12.06.2024, the PIO, stating that the information sought for by the appellant is too voluminous and against multiple number of schemes pertaining to multiple number of Financial Years owing to which he needs sufficient time to collate and collect the information.

The Commission considered the submission of the PIO and accordingly directed the PIO to provide the sought for information in a phased manner pertaining to SIDF, CMCSR and MLALAD schemes starting with the FY 2016 onwards on or before next date of hearing i.e. 24.07.2024.

In today's hearing, the appellant is absent without any information but the APIO o/o the E.E (PWD), Pake Kessang is present who brought in some part of information to be handed over to the appellant. But since the appellant is absent the documents are returned to the APIO with direction to contact the appellant and hand over the same to him. The appellant is also directed to contact the o/o the PIO and collect the information and intimate his satisfaction or otherwise before the next of hearing.

**The next date of hearing of this case is fixed on 20<sup>th</sup> September, 2024 (Friday) at 02.00 P.M**
