## **SUMMON**

WHEREAS, in connection with the APIC-No. 736/2023, your personal appearance is required before the Commission on 7th October, 2025 at 02:30 PM. The 3rd hearing held on 3rd July, 2025' related to the APIC No-730/2023. The Appellant Shri Tamchi Gungte is absent with a letter of absence citing the reasons that he has got another hearing at the office of the Chief Engineer, PHE & WS, West Siang District today, therefore, he has requested the court to postpone the hearing on another date. He also stated that the PIO has not furnished the information(s) him till date.

- The PIO to provide all the information(s) which are available in the office of the PIO ii) on or before the next date of hearing.
- To summon the Appellant to be present on the next date of hearing m, failing which iii) the instant appeal shall be heard and determined, ex-parte.

The next date of hearing be fixed on 7th October, 2025' at 2:30 PM (Evening)
