ORDER

The 2nd hearing held on 30th July 2024 related to the APIC No 196/2024. The Appellant Shri Niaye Lingri present the hearing but the PIO found absent consecutively for two times i.e on 18.06.2024 & 30.07.2024 without intimating to the Commission the reason for his inability to attend the hearing which is unbecoming on the part of the PIO, who has to be reminded that the PIO beside public duties also has to attend Court hearings when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

The Appellant stated before the Commission that he has not received any of the information (s) from the PIO as sought in his form 'A' application till today hearing.

After hearing the Appellant and going through the available documents viewed seriously on the absence of the PIO and order:

- (i) To issue warning summon to the PIO to appear in person or through online mode before the Commission in the next date of hearing.
- (ii) The PIO to provide all the information(s) to the Appellant as applied in his application on or before next date of hearing as sought in his form 'A' Application. Failing which the provisions under section 20(1) shall be initiated against the PIO as per the provisions of RTI Act, 2005.

The next date of hearing be fixed on **3rd Sept 2024 at 2.30 PM** (Afternoon)

Next date of hearing has been intimated to the Appellant. No formal notice required to be issued.
