Order.

The 1st hearing held on <u>26th September,2024</u> related to the <u>APIC No-224/2024</u>. The representative of PIO Er. Jomnya Jini, AE present during the hearing but the Appellant found absent without intimating the reason for his inability to attend the hearing.

Heard the representative of the PIO.

The representative of the PIO stated that, the information(s) sought by the Appellant is completely provided under the detailed project report (DPR) and he has brought a copy of the DPR along with him to provide the Appellant during the hearing. However, the representative of the PIO could not hand over the said information(s) due to the absence of the Appellant in the hearing.

After hearing the representative of the PIO, the Commission ordered;

- (i) The representative of PIO to communicate with the Appellant and provide the information(s) to the Appellant on or before next date of the hearing. Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act, 2005.
- (ii) To issue <u>summon</u> to the Appellant to appear before the Commission in person or through online mode in the next date of hearing. Failing which his appeal shall be decided as exparte.
- (iii) The next date of hearing has been intimated to the representative of PIO. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 19th November, 2024 at 2:30 PM (Afternoon)
