This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho, for non-furnishing of information by the PIO Project Director DRDA Koloriang, Kurung Kumey, Govt. of Arunachal Pradesh. Pin :791118 as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

This appeal is heard for the 2nd time today on 24.7.2024.

The Appellant, Shri Bamang Pacho is present but the PIO is absent in today's hearing also which has been viewed seriously by this Commission.

The Appellant reiterated his request for the information from the PIO and pleaded the Commission to take stringent action against the PIO for his failure to attend the hearing despite notice.

This Commission, taking serious note of the continued failure on the part of the PIO to attend the hearing either in person or through a representative, is constrained to direct the PIO to attend the next hearing to present his case failing which necessary action under the relevant provisions of the RTI Act shall be initiated against him.
