The 8th hearing was held on 2nd **DEcember, 2024** related to the **APIC No-924/2023 (Appeal)**. Appellant Shri Buli Bhai present during the hearing but PIO-cum-EE (PWD), Raga Division found absent without any information to the Commission.

As per the Form 'A' application, the appellant has sought information from 2015 to till date regarding the expenditure and implementation of scheme under SADA/ADA/SIDF/RE/RIDF/BE under Kamle District. The PIO has stated before the Commission that he would not be able to provide the information in such voluminous in nature and requested to curtail the information for single financial year i.e. 2022-2023. The appellant has agreed to curtail the information for the period from 2022-2023 of the scheme as mentioned. The PIO has agreed to furnish the information in phase wise basis in all projects.

But till date PIO failed to furnish the documents. Commission directs the PIO to furnish the documents as sought by the appellant and also directed to present in person before the Commission in the next date of hearing, failing which necessary action shall be taken against the PIO as per the RTI Act, 2005.

The Commission also directed the appellant to appear in person before the Commission in the next date of hearing. Failing which, his appeal shall be decided as ex-parte and dispose of.

The Commission fixed the next date of hearing on **13/01/2025 at 1030 hours.**
