**ORDER**

The 2<sup>nd</sup> hearing held on 30<sup>th</sup> July 2024 related to the APIC No-192/2024. The Appellant Shri Nabam Tai and the PIO found absent without intimating to the Commission the reason for their inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a salutary duty binding upon the PIO.

The Appellant stated before the Commission that as per the order passed in the last hearing dated on 18.06.2024, the PIO has furnished the information of only no **7,8 & 13**, as sought in his form

‘A’ application but the other information have not been provided to him.

After hearing the Appellant and going through the available documents the Commission orders:

- (i) To issue warning summon to the PIO to appear in person or through online mode before the Commission in the next date of hearing.
- (ii) The PIO to provide all the left out information’s to the Appellant on or before next date of hearing as sought in his form ‘A’ application. **Failing which the provisions under section 20(1) shall be imitated against the PIO as per the provisions of RTI Act 2005.**

The next date of hearing be fixed on **3<sup>rd</sup> Sept 2024 at 2.30 PM (afternoon)**

Next date of hearing has been intimated too the Appellant. No formal notice required to be issued.

The next date of hearing be fixed on **3<sup>rd</sup> Sept 2024 at 2.30 PM (afternoon).**
