**SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tall Yitor, for non-furnishing of information by the PIO DFO Daporijo Forest Division Upper Subansiri District Govt. of Arunachal Pradesh. as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

This appeal is heard for the 4<sup>th</sup> time today on 11<sup>th</sup> September, 2024 wherein the appellant Shri Tall Yitor attended the hearing through video conference but the PIO, o/o DFO Daporijo Forest Division, Upper Subansiri District, AP was absent.

In the second hearing, this Commission had directed the Appellant to collect the information from the PIO by 29-07-2024 as advised by the PIO and intimate his satisfaction or otherwise on or before next date of hearing.

However, in the next date of hearing on 28-08-2024 (3<sup>rd</sup> hearing) both the parties did not turn up and as such the hearing was adjourned to 11<sup>th</sup> Sept. 2024.

In today's hearing the appellant informed the Commission through VC that he has been informed by the PIO that the documents were handed over to one of his (appellant's) relatives from whom he will collect the same and inform his satisfaction or otherwise to the Commission.

The Commission considered the request of the appellant and fixed the next date of hearing on **4<sup>th</sup> Oct. 2024 at 02.00 pm.**
