Summon Notice.

The 1st hearing held on **7th November, 2024** related to the **APIC No-692/2023**. The PIO is represented by his APIO-cum-Assistant Engineer, RWD, Pakke Kessang, Shri Tagir Taring. The Appellant Shri Riya Taram found absent during the hearing without intimation to the Commission for his inability to attend the hearing.

Heard the PIO:

The representative of the PIO stated that he has not yet received the Form-A application from the Appellant as the Appellant has sent the application through Postal Service and the PIO does not have a regular office at Pakke Kessang and therefore, it might have been the reason for not delivery of the application of the Appellant as the PIO is presently functioning from Itanagar in a make shift office.

After Hearing the APIO and going through the Form A application of the Appellant, the Commission ordered;

- (i) The Form-A application be provided to the PIO, by the Commission After receipt of the Form-A application of the Appellant through the State Information Commission, the PIO is directed to provide all the information(s) as sought in Form-A application on or before next date of hearing. ***Failing which necessary action shall be initiated against the PIO as per the provision of RTI, Act, 2005.***
- (ii) ***To summon the Appellant to appear in person or through online mode in the next date of hearing. Failing which his appeal shall be decided ex-parte.***
- (iii) Next date of hearing has been intimated to the APIO. No formal notice required to be issued.

The Form-A of the Appellant is provided to the APIO.

The Commission ordered;

The next date of hearing be fixed on 19th December, 2024 at 10:30 AM (Morning)
