Summon Notice.

The 1st hearing held on 3rd December, 2024 related to the APIC-No-734/2023. The Appellants Shri Dugi Sakam and Yukar Talar found absent without intimation to the Commission about their inability to attend the hearing. The PIO-cum-BDO, Raga, Kamle District, Govt. of Arunachal Pradesh, is present in person during the hearing.

Heard the PIO:

The PIO stated that the Appellants had failed to comply the hearing order fixed by the First Appellant Authority (FAA) on 27.07.2023, wherein the PIO was represented by S. Nigam, GRS (Gram Rojgar Shayak), but the Appellants did not turn-up, without intimating the reason about their absence. The PIO on 14th day of March' 2023, sent a letter to the Appellants Mr. Dugi Sakam and Yukar Talar to deposit an amount of Rs. 10/- per page of the information(s) as per prevailing market rate and the information(s) consist of 6121(six thousand one hundred twenty one) pages till now Appellants did not submit the fees to the office of the PIO. And the same letter was served to the wife of the Appellant, Yukar Talar, Smti. Yukar Moyena as Dasti-Service, but till today the Appellants have not responded. And going through the Form-A of the Appellants they have asked the information(s) from the year 2017 to 2023 which is running to 6 (six) years and numbers of information(s) applied by the Appellants are also running to huge 26 numbers of information(s) out of which some of the information(s) may also be exempted as coming under THIRD PARTY information(s).

The Commission ordered:

- (i) Due to the absence of both the Appellants in first hearing of this appeal, the case is postponed for the next hearing.
- (ii) Summon notice be issued to both the parties to appear in person or through online mode before the Commission in the next date of hearing.
