ORDER

The 3rd hearing held on **26th November 2024**, related to the **APIC No-178/2024**. The PIO found absent without intimating to the Commission the reason for his inability to attend the hearing but the Appellant Shri Pate Mesi Lomdak present through online mode during the hearing.

Heard the Appellant.

The Appellant stated before the Commission that he has received some of the information from the PIO as sought in his form 'A' application but the information was incomplete and Appellant specially asks for serial no. 8 pertaining to seniority list of the staffs for SE A.P, Electrical Circle -V, Department of Power.

In the last hearing, the PIO stated before the Commission that as per the order passed by this Court in the last hearing on dated 11/06/2024 and consequent upon the said order, the PIO has directed the concerned Executive Engineers of different Districts and Divisions to provide the information(s) but till now, some of the EE-cum-PIO's are not providing the information(s) to the Appellant.

Due to absence of the PIO, the Commission could not proceed the hearing of this appeal and Commission ordered;

- (i) ***To PIO to provide all the information(s) to the Appellant as well as the information sought in serial no 8 pertaining to seniority list on or before next date of hearing. Failing which action section 20(2) shall be initiated against the PIO as per the provision of RTI Act 2005.***
- (ii) ***The concern Competent Authority, EE-cum-PIO's of respective Divisions to provide the complete information(s) to the Appellant on or before the next date of hearing. Failing which necessary action shall be initiated against the Division's concern PIO's as per the provisions of RTI Act, 2005.***

(iii) Next date of hearing has been intimated to the PIO. No formal notice required to be issued.

The Commission ordered:

The next date of hearing be fixed on 4th February 2005 at 1.30 PM (Afternoon).
