## <u>ORDER</u>

The  $2^{nd}$  hearing held on  $16^{th}$  January 2025, related to the **APIC** No. 1170/2023(Appeal). The PIO present through online mode during the hearing and the Appellant Shri Riya Taram, present during the hearing.

Heard both the parties.

The PIO stated that he has already intimated to the Appellant on dated 15/09/2023, that the information sought by them in Form 'A' application are too voluminous to be provided in one go as well as ambiguous and not specific and spanning for 8 yrs time w.e.f **2016 to 2024**. The PIO stated before the Commission that the PIO's, office is very busy in other public works and hence, they are not able to devote their time in only providing information(s) under RTI Act to the Activists seeking for information(s) spanning for too many years like in the instant appeal.

Therefore, the PIO had written to the Appellant to resubmit a fresh application for providing specific information to on time, the information(s) that are not too voluminous, but till date the Appellant has not submitted a fresh application to the PIO or even written or communicated back to the PIO.

The Appellant stated that during the 2<sup>nd</sup> hearing the Appellant has minimized his information list that he wants and he now is seeking only the information for JJM Scheme and contractor list which are related to JJM schemes.

## The Commission observed;

After hearing both the parties and going through the form 'A' application of the Appellant. The Commission observed that Appellant has minimized list of information(s) sought and therefore, it will be easier for the PIO to provide the specific information to the Appellant.

## And therefore, the Commission ordered;

- (i) The PIO to provide the information(s) pertaining to JJM Schemes to the Appellant on or before next date of hearing.
- (ii) The next date of hearing has been intimated to both the parties. No formal notice required to be issued.

The Commission ordered;

The next date of hearing is fixed on 18<sup>th</sup> March 2025 2.30 PM (Afternoon).
