ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Teli Ango, & Mr. Nagbia Kyokam, C/o Gauhati High Court Itanagar Permanent Bench, Yupia Naharlagun, PO/PS Naharlagun, District Papum Pare, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 18/11/2024 regarding PMGSY Road from Ompuli to Tamang Village, Toru Circle under Sagalee ST. Constituency District Papum Pare (A.P).
- 2). The 1st hearing was held on 29th April, 2025. The PIO-cum-EE (RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh was represented by Shri Tagur Yowa, JE (RWD) Sagalee Division. The Appellant Adv. Teli Ango was present.
- 3). The Appellant Adv. Teli Ango had submitted that the PIO has furnished information just before the hearing, so appealed the Commission to give time to go through the information furnished by the PIO.
- 4). The Commission on appeal of the Appellant, had given reasonable opportunity, to go through the information furnished by the PIO and intimate to the Commission of his satisfaction or dissatisfaction.
- 5) The Appellant vide letter No. NIL dated 19th May, 2025 has submitted that the information furnished by the PIO are incomplete and appealed the Commission for fixation of date of hearing.
- 6). The Commission, hereby giving reasonable opportunity to both the parties fix one more date of hearing.
- 7). The Next date of hearing is fixed on 8th July, 2025 (Tuesday) at 1100hrs.
- 8). Both the parties are directed to appear on the day of hearing mentioned above. If the PIO is found absent, penalty under section 20(1) of the RTI Act, 2005 shall be invoked on him/her and in case the Appellant is found absent the appeal case shall be disposed of.
