**ORDER**

WHEREAS, in connection with the **APIC-No. 207/2024**, your personal appearance is required before the Commission on **14<sup>th</sup> November, 2024 at 10:30 AM**. The Appellant Shri Riddam Kato and the PIO found absent without intimating to the Commission the reason for their inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the RTI, Act, 2005, which is a statutory duty binding upon the PIO. And the appellant also absenting in the hearing without intimation to the Commission, of his inability to attend the hearing makes the Commission deem that the Appellant is not serious on his appeal.

Viewing seriously on the absence of both the parties: the Commission ordered;

- (i) To **summon** both the parties to appear in person or through online mode before the Commission in the next date of hearing.
- (ii) **Failing which necessary action shall be initiated against both the parties as per the provisions of RTI, Act, 2005 and therefore;**

The Court ordered;

**The next date of hearing be fixed on 14<sup>th</sup> November, 2024 at 10:30 AM (Morning)**
