**SUMMON NOTICE.**

The 1<sup>st</sup> hearing held on 16<sup>th</sup> July, 2025 related to APIC No-143/2025(Appeal). The PIO-Cum-EE (PWD), Bomdila Division is represented by the Er. Achung Bagang, APIO but the appellant Shri Mamu Sono found absent without any information to the Commission.

As per the case record it is seen that the hearing was conducted before the First Appellate Authority and order was passed by the FAA on the second hearing dated 06/02/2025 at 1100 hours. Both the parties were respondent and appellant were present during the hearing. The appellant was directed to collect information sought from the office of the PIO and intimate within 15 days before the First Appellate Authority, that whether he was satisfied by the information furnished.

The FAA stated clearly in his order that if the appellant is not intimating within 15 days. It will be presumed that he is fully satisfied with the information furnished by the PIO and the final order will be passed.

The PIO has stated today before the Commission that the same subject matter was also been heard before former State Information Commissioner, Shri Gumjum Haider. The PIO also stated that the information was already kept to be furnished as per the order made by the former SIC, but appellant never turned up.

The appellant is directed to collect the information from the office of the PIO\_Cum-EE (PWD), Bomdila Division and intimate before the Commission on or before the next date of hearing. If he is found absent on the next date of hearing without any intimation to the Commission, it will presume that the information sought has already been provided and he is no more interest to pursue the case. The case will be decided in his absence if found absent in the next date of hearing.

The Commission adjourned the hearing and fixed next date of hearing on **04/08/2025 at 1030 hours.**
