**WHEREAS**, in connection with the APIC-No. 100/2024, your personal appearance is required before the Commission on 6<sup>th</sup> June, 2024 at 2:30 Pm. In the last hearing on 9<sup>th</sup> May, 2024 the Appellant were absent during the hearing nor they intimated the reason for their absence to the Commission.

**WHEREAS**, the 1<sup>st</sup> hearing held on 7<sup>th</sup> May, 2024 related to the APIC No-100/2024. The PIO present during the hearing but you found absent without intimating the reason for your inability to attend the hearing.
