ORDER

The 5th hearing held on 21st January, 2025 related to the APIC-No-139/2024. The Appellant Shri Pem Dondup Thongkhar is present through online mode. The PIO-cum-EE, PWD, Dirang Division, West Kameng District, Govt. of Arunachal Pradesh, is represented by Shri Tapi Mali, Assistant Engineer (AE) PWD, Dirang Division, during the hearing before the Commission.

Heard the Appellant and the PIO:

The representative of the PIO stated that the information(s) sought by the Appellants under Form-A application of RTI, Act, 2005, is not understandable and so, the department did not understand which office is dealing with the works as applied for information(s) by the Appellants and also informed the Commission that the PIO has written to the Appellants on 2nd November' 2024, that they not executing any such project as written on their application by the Appellants.

The Appellant stated that the letter written by the PIO is not related to the information(s) which they have sought in their Form-A application.

After hearing both parties;

The Commission rectified the Form-A application of the Appellants in presence of the APIO and the Appellants. And the APIO agreed to provide the information(s) to the Appellants after understanding the contents of the Form-A of the Appellants, after clarification from the Commission.

The Commission ordered:

- (i) The PIO to provide all information(s) sought by the Appellants which are with the office of the PIO.
- (ii) Notice for the next date of hearing need not be issued to both the parties as they are present personally during the hearing.

The Commission ordered;

The next date of hearing be fixed on 20th March' 2025 at 10:30 AM (Morning).
