**SUMMON.**

**WHEREAS**, in connection with the **APIC-No. 334/2024**, your personal appearance is required before the Commission on **30<sup>th</sup> October, 2025 at 10:30 AM**. The 2<sup>nd</sup> hearing held on **22<sup>nd</sup> July, 2025**. The Appellants Shri Nibo Pao and others are absent, but Nibo Pao has submitted a letter of absence to the Commission and prayed for deferring the hearing to another date.

**Heard the PIO;**

Then the Appellant preferred an appeal before the First Appellate Authority (FAA). The FAA passed a judgment to provide information(s) for one year which is for 2024 being the latest one out of the information(s) sought, on dated 22.11.2024 and accordingly the PIO furnished the information(s) to the Appellant on 05.12.2024.

As the Appellants are absent to verify the statement of the PIO **the Commission hereby orders as follows;**

- i) Summons be served to the Appellants to attain the next date of hearing in person or through online mode without fail, failing which this instant appeal will be heard and determined ex-parte.
- ii) Notice need not be issued to the PIO as he is present during the hearing before the Commission.
