## **SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho, for non-furnishing of information by the PIO Project Director DRDA Koloriang, Kurung Kumey, Govt. of Arunachal Pradesh. Pin:791118 as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

This appeal is scheduled for hearing for the 4<sup>th</sup> time today on 11<sup>th</sup> September, 2024 but the Appellant Shri Bamang Pacho is present while the PIO o/o the PD DRDA, Koloriang, Kurung Kumey District, A.P. is yet again absent, despite summon notices and telephonic advice by this Commission to attend the hearing. Such continued absence of the PIO in the hearing has been viewed by this Commission as blatant disrespect to the Commission and to the RTI regime. The appellant, Shri Bamang Pacho who is also equally disappointed with the continued absence of the PIO, pressed for taking action against the PIO under the RTI Act.

In the premises aforesaid, there is no option left for this Commission but to issue show cause notice to the PIO as to why stern action under the relevant provision of the RTI Act should not be taken against him. Hence, this Commission decides to issue show cause notice to the PIO who shall submit his reply by the next date of hearing and to appear personally.

## The next date of hearing is fixed on 9th October, 2024 at 10.30 am.

**NOW THEREFORE** the PIO, Project Director DRDA Kolorieang, Kurung Kumey District, Pin 791118 Govt. of Arunachal Pradesh is hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person or online on the above-mentioned date and time without fail.
