**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, for non-furnishing of information by the PIO –cum-EE, (PWD), Yingkiong Division, Upper Siang District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005.

This appeal was fixed for hearing for seven times. In some of the hearings either the Appellant or the PIO or both were absent.

In the 4<sup>th</sup> hearing held on 22-05-2024 wherein the representative of the PIO, Shri Rajendra K.N, Junior Estimator, was present but appellant was absent. The representative of the PIO brought in the authenticated/certified document to be handed over to the appellant who collected the same from this Commission on 24/05/24. The appellant was directed to go through the documents so provided to him and inform his satisfaction or otherwise to the Commission on or before the next date of hearing on 19-06-24. However, the parties did not turn up for hearing on 19.06.2024. In the hearing on 24.07.2024 also, the parties did not turn up.

This Commission taking serious view of the continued absence of the parties particularly, the appellant observed that the appellant is no longer interested in the information he had sought and accordingly expressed its inclination to dispose and close the appeal. However, the Commission allowed a last opportunity to the parties to comply with its direction contained in earlier order dated 22-05-2024 and adjourned the hearing to 28-08-2024 and accordingly summons were issued to the parties.

In today's hearing on 28.08.2024 fixed for 7<sup>th</sup> times, the appellant, Shri Riya Taram was again absent but APIO Shri J P Pandey, ASW o/o PWD, Yingkiong Division, Upper Siang Dist. Attended through VC who submitted that the sought for information have been furnished to the appellant on 22th May, 2024 which the Appellant was to go through and report his satisfaction or dissatisfaction to the Commission as directed by this Commission.

For the continued absence of the appellant in the hearings despite categorical and unequivocal orders of this Commission in its earlier hearings, this Commission is of the view that the appellant is satisfied with the information provided on 22/05/24 and collected by him on 24.05.2024 and therefore, requires no further information from the PIO and also no further intervention of this Commission.

In the premises as above, the Commission deems it fit to dispose of and close the appeal for once and for all which the Commission hereby does.
