**ORDER**

The 1<sup>st</sup> hearing held on **28<sup>th</sup> November, 2024** related to the **APIC-No-1055/2023**. The Appellant Shri Tagi Ruti is absent. The PIO-cum-EE, PHE & WS, Department, Likabali Division, Lower Siang District, Govt. of Arunachal Pradesh, found absent during the hearing without intimating to the Commission the reason for their inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties. Govt. of Arunachal Pradesh is found absent for three consecutive hearings.

The Commission ordered:

- (i) The absence of both the parties in first hearing of this appeal, the case is postponed for the next hearing .
- (ii) Summon notice be issued to the PIO to appear in person or through online mode before the Commission in the next date of hearing, failing which appropriate action shall be initiated against him as per the provision of RTI, Act, 2005.
- (iii) Notice also be issued to the Appellant to appear in person or through online mode before the Commission in the next date of hearing, failing which the appeal will be decided ex-parte.
