The 8<sup>th</sup> hearing was held on 30<sup>th</sup> October, 2024 related to the APIC No-927/2023 (Appeal). Both the parties, Appellant Shri Palen Laa and PIO-cum-DFO, Hapoli Forest Division found absent, without any information to the Commission.

Show Cause Notice was issued by the Commission on 18/9/2024 and the reply of the show Cause has been received from the PIO-cum-DFO, Hapoli Forest Division, Ziro which is enclosed.
