SUMMON

WHEREAS, in connection with the **APIC-No. 132/2025**, your personal appearance is required before the Commission on **14th October, 2025 at 02:30 PM**. The **1st hearing held on 8th July, 2025**. The Appellant Shri Tai Patum is absent without intimating the Commission the reason for his inability to attend the hearing. The PIO-cum-DDSE, Upper Subansiri District, Daporijot, Govt. of Arunachal Pradesh, found absent during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

- ii) **Summon** be issued to the Appellant to be present in the next date of hearing in person or through online mode without fail, failing which this instant appeal will be heard and determined Ex-parte.
