Summon Notice

The 5th hearing was held on 9th December, 2024 related to the **APIC No-11/2023 (Appeal)**. Appellant Shri Bini Toluk present during the hearing but the PIO-cum-EE (PWD), Raga Division found absent without any intimation to the Commission.

On the 4th hearing dated 18/11/2024, Show Cause Notice was issued to the PIO as to why not impose the Sub-section-1 of the Section-20 against the PIO for the gross violation of the Sub-Section-1 of the Section-7 of the RTI Act, 2005 and the PIO was directed to reply of the notice immediately and also directed to appear before the Commission in the next date of hearing. But he failed to comply the direction of the Commission.

The Commission viewed serious on the reluctant attitude of the PIO to reply the Show Cause notice issued on 4th hearing and consecutively absent 3(three) hearing dated 28/10/2024, 18/11/2024 and 09/12/2024. So, the Commission issue Last Warning Show Cause Notice to the PIO as to why not impose the Sub-section-1 of the Section-20 against the PIO for the gross violation of the Sub-Section-1 of the Section-7 of the RTI Act, 2005 and the PIO and directed to reply of the notice immediately.

The appellant is directed to intimate same to the Commission on or before next date of hearing.

Commission adjourned the hearing and fixed next date of hearing fixed on **03/02/2025 at 1030 hours.**
